## **Background & Rationale**

### I. About BEPC

Bihar Education Project Council (BEPC) an autonomous body of Education Department, Govt. of Bihar, has now completed more than two and half decade in implementing various education programmes in the state up to Secondary/ Sr Secondary level. At the onset, BEPC had successfully implemented World Bank assisted five-year District Primary Educational Programme (DPEP) which concluded in the Financial Year 2005-06 in eleven educational districts i.e. twenty revenue districts of Bihar as State Implementation Society (SIS).

The council has also honor of successfully implementing the Government of India sponsored ten-year Sarva Shiksha Abhiyan (SSA) as State Implementation Society (SIS) in all the 38 districts of Bihar. One Society, namely "State Programme for Elementary Education Development (SPEED)" which was earlier implementing the SSA in four districts (Saharsa, Nalanda, Patna and Supaul) has also been merged with BEPC as per the decision of the state Government.

Bihar Education Project Council has now been entrusted to implement Samagra Shiksha, a holistic school education programme in the backdrop of National education Policy, 2020 after the successful implementation of BEP, DPEP III, Sarva Shiksha Abhiyan along with NPEGEL. Considering the approval of Cabinet Committee on Economic Affairs, the Samagra Shiksha Abhiyan- an integrated scheme for school education (ISSE), Bihar Government has taken decision to run this centrally sponsored Scheme which has submerges three schemes of Sarva Shiksha Abhiyan (SSA), Rashtriya Madhyamik Shiksha Abhiyan (RMSA) and Teacher Education (TE) through the Bihar Education Project Council (BEPC) – the single State Implementation Society (SIS). The integrated scheme on School Education envisages the school as a continuum from pre-school, primary, upper primary, Secondary to Senior Secondary levels. The vision of the scheme is to ensure inclusive and equitable quality education from pre-school to senior secondary stage in accordance with Sustainable Development Goal (SDG) for Education.

### II. Rationale for Sanitary Pad Vending Machine & Incinerators

Menstruation is a normal biological phenomenon. However, there are various socio-cultural and infrastructural limitations that limit the ability of girls and women to practice safe and effective menstrual hygiene management. Given this, healthy menstruation and menstrual hygiene management is intimately linked with several Sustainable Development Goals (SDG), including SDG 2 on "Good Health and Wellbeing", SDG 4 on "Quality Education", SDG 5 on "Gender Equality", and SDG 6 on "Clean Water and Sanitation". The National Family Health Survey (NFHS)-5 data shows that the women age 15-24 years who use hygienic methods of protection during their menstrual period is only 58.8% in the State. Therefore there is much



more need in promotion of safe menstrual hygiene management in the State specially for school going adolescent.

National Education Policy (NEP) para 4.28 says that 'basic training in health, including preventive health, mental health, good nutrition, personal and public hygiene, disaster response and first-aid will also be included in the curriculum'. Access to information, access to products, access to WASH facilities and menstrual waste management is the key strategy to be able to promote safe menstrual hygiene management at various levels including households and institutions especially the girls schools. Therefore, state has decided to provide sanitary napkin vending machines along with the incinerators to 93 selected schools @ Rs.32,000/- per school of Bihar for safe disposal of used sanitary napkin.

This initiative will make the girl students be able to understand importance of Menstrual Health & Hygiene Management related issues and provide a safe and secure environment in school. Also teachers will provide guidance & counseling, sensitization, awareness generation on menstrual health for students.

### Scope of Work

1. The prospective bidder(s)/vendor(s) are required to install sanitary pad vending machine and incinerator in all 46 elementary and 47 secondary (total 93) selected school in all 38 districts. School list will be provided by BEPC, Patna.
2. The hardware (vending & incinerator machine) will be supplied to each of the selected school by vendor.
3. Free maintenance will be done at-least 1 year from the date of installation.
4. The vendor shall also provide one day (1 day) product handling training to two teachers from each school in consultation with BEPC, Patna
5. Purchase of machines will be done by schools directly.
6. Payment will be made directly by schools and certification letter will be submitted to respective District Education Officer/District Program Officer (EE&SSA).





## SECTION-I

### General Terms & Conditions

#### Goals of the Expression of Interest (EoI)

The objective of this EoI is to solicit proposals from the interested eligible reputed OEM/Companies/Firms having the latest technologies to supply the product in 93 schools located in the different districts of Bihar.

The EoI proposal should include followings: -

- 1) A Detailed company profile which should include details of authorized representative.
- 2) All Documentary Evidence to suffice the eligibility and pre-qualification criteria.
- 3) Details of Product along with detailed technical specifications.

The concerned committee of the Council will examine the eligibility as well suitability of the EoI proposal submitted by OEM/Company/Firm in consonance with the requirements set forth in the EoI document as well as other requirements of the Council and selected OEM/Company/Firm would be further invited for a detailed technical presentation-cum-demonstration based on which a RFP will be devised considering the quality, cost, effectiveness, robustness and scalability.

## SECTION - III

**Bidding Terms & Eligibility/Pre-Qualification Criteria****Conditions under which this EoI is issued**

- i) This EoI is not an offer and is issued with no commitment. The Bihar Education Project Council reserves the right to withdraw the EoI and change or vary any part thereof at any stage. The Council also reserves the right to disqualify any bidder, should it be so necessary at any stage.
- ii) Council reserves the right to withdraw this EoI if the Council determines that such action is in the best interest of the Government of Bihar.
- iii) Short-listed bidders would be intimated separately for the detailed technical presentation as well as for the demonstration of products.
- iv) No conversations or agreements with any official, agent, or employee of the Council shall affect or modify any terms of this EoI and any alleged oral agreement or arrangement made by a bidder with any department, agency, official or employee of Govt. of Bihar shall be superseded by the definitive agreement that results from this EoI process. Oral communications by Council/Department to bidders shall not be considered binding on the Council/Department, nor shall any written materials have provided by any person other than the Council/Department.
- v) Neither the Bidder nor any of the Bidder's representatives shall have any claims whatsoever against the Council/Department or any of their respective officials, agents, or employees arising out of, or relating to this EoI or these procedures (other than those arising under a definitive service agreement with the bidder in accordance with the terms thereof).

Council shall not be bound by any language in the proposal indicating the confidentiality of the proposal or any other restriction on its use or disclosure.



## Acknowledgement of Understanding of Terms

By submitting a proposal, each Bidder shall be deemed to acknowledge that it has carefully read all sections of this EoI, including all forms, schedules, and annexure hereto, and has fully informed itself as to all existing conditions and limitations.

## Evaluation of Proposal

The bidders' Proposal will be evaluated as per the requirements specified in the EoI and adopting the pre-qualification criteria spelt out in this EoI. Prospective bidders are required to submit all required documentation in support of the pre-qualification/eligibility criteria as required for evaluation. The bidder should ensure that EoI proposal are properly indexed, page numbered, signed with seal on each page by the Authorized representative of the OEM/Company/Firm.

## Language of Proposals

The proposal and all correspondence and documents shall be written in English.

## Submission of Proposals

The Proposal should be submitted in the sealed envelope with all documentary evidence in support of eligibility / prequalification criteria as well as detailed presentation, products details and technical specifications, cost breakup etc. as specified in this EoI.


