## आवश्यक सूचना

PR-009505 (Ni.Ni.) 2022-23 के द्वारा समग्र शिक्षा की वार्षिक कार्य योजना एवं बजट 2022-23 में पुस्तकालय अनुदान अन्तर्गत स्वीकृत राशि से बिहार राज्य के सभी सरकारी विद्यालय के पुस्तकालयों के लिए "हिन्दी/उर्दू/अंग्रेजी एवं क्षेत्रीय/स्थानीय भाषा (मैथिली/भोजपुरी/अंगिका/बज्जिका/मगही/जनजातीय भाषा-सूर्यापुरी/उरांव आदि)" की पुस्तकें क्रय करने हेतु इस कार्यालय द्वारा प्रकाशित अभिरूचि की अभिव्यक्ति (EOI) के द्वारा देश/राज्य के प्रतिष्ठित निजी प्रकाशक से दिनांक 19 नवम्बर, 2022 को अपराह्न 04:00 बजे तक आवेदन पत्र आमंत्रित किया गया था। निर्धारित तिथि तक प्राप्त (कुल 254) की सूची के क्रम संख्या 10 एवं 33 तथा 11 एवं 34 पर अंकित फर्म का नाम एक ही है। साथ ही, सूची के क्रम संख्या 158 पर अंकित फर्म- विद्या प्रकाशन मंदिर प्रा० लि० के द्वारा मात्र अनुरोध पत्र दिया गया है। इस तरह कुल 251 निजी प्रकाशकों का पूर्ण रूपेण प्रस्ताव प्राप्त हुआ है।
