In light of the decision of the Purchase Committee dated August 11, 2021, the report of the Technical Evaluation Committee as well as the proceedings of the Purchase Committee were uploaded on the portal of BEPC namely <a href="https://www.bepcssa.in">https://www.bepcssa.in</a> to maintain transparency in the process.

Further, in light of the decision of the Purchase Committee, comments /observations, and additional information in-line with the EOI document already submitted were sought from the respective bidders in support to their EOI document already submitted latest by 25<sup>th</sup> August 2021. It was also clarified that document to be submitted must be of earlier dates i.e. before the last date of submission of EoI i.e. 31/05/2021.

In response to the decision of the Purchase Committee, documents / supplementary information were obtained from only 7 bidders by the stipulated date i.e. 25<sup>th</sup> August, 2021.

In order to examine the responses of the bidders based on the comments / observations and additional information, an evaluation committee was constituted vide Letter No. MIS/SS/29/2020-21/5494 dated 31/08/2021. The Committee thus formed for this purpose, submitted its evaluation report dated September 03, 2021, indicating position of each bidder with reference to the pre-qualification /Eligibility criteria where clarification was sought and will form part of the proceedings as Annexure-I.

The report of the Technical Evaluation Committee was further perused by the Purchase Committee regarding responsiveness of the bidders. The observations, conscious decisions and recommendations of the Purchase Committee are as follows: -

- (1) In spite of submission of comments/observations and additional information by bidders, finally out of 10 bidders, only one bidder fully meets the pre-qualification/eligibility criteria and remaining nine bidders could not meet the pre-qualification / eligibility criteria as set forth in the EOI.
- (2) In-spite of inviting the EoI for the 2nd time, only one bidder could meet the pre-qualification/eligibility criteria set forth in the EoI, the Purchase Committee unanimously took decision to conclude the process of EoI and to initiate the process of floating RFP to save the time.
- (3) Further, it was also decided to invite the only successful/pre-qualified bidder M/s. Uneecops Technologies Ltd., New Delhi to make a technical presentation /elaboration on the business processes and application solution components and to provide their valuable technical inputs to the department in devising a well thought RFP.
- (4) Based on the RFP, the department will invite an open tender under eprocurement method.

The meeting ended with a vote of thanks to the Chair.
